CCPS is seeking to gather accurate data on workforce pressures. The survey is open to all third sector social care providers and we wish to encourage all providers of housing support working in the voluntary sector to take part. We will circulate a link to the survey early next week.

## Consultation: Enhancing the accessibility, adaptability and usability of Scotland's homes

The Scottish Government is currently consulting on enhancing the accessibility, adaptability, and usability of Scotland's homes. The consultation aims to improve housing accessibility through the review of Part 1 of the Housing for Varying Needs design guide and by introducing a Scottish Accessible Homes Standard through updates to building standards and guidance. Part 2 of the Housing for Varying Needs design guide, which focuses on provision for housing with integral support, is not within the scope of this consultation. The consultation states that this reflects the shift to more care delivered at home, and that most older and disabled people live in homes without integral support and want to continue to do so as long as possible.

#### **Ending Homelessness Together: Annual Report 2023**

The Scottish Government has published the <u>2023 annual report</u> about progress made in the last 12 months by national government, local government and third sector partners towards ending homelessness in Scotland. The report notes the challenges of the past year and reiterates that the Scottish Government and COSLA are committed to a 'no wrong door' and person -centred approach to homelessness services. This will be supported by new homelessness prevention duties, set to be introduced in the Scottish Government's housing bill during 2023-24. As part of the



progress against actions to prevent homelessness from happening in the first place, the report states that the Scottish Government will consider and respond to the recommendations of the <u>task and finish group on homelessness prevention</u>, as well as focusing on tenancy sustainment to avoid evictions into homelessness.

# CCPS Digifest Satellie Session: Opportunities and risks in integrating social care data and health data

CCPS is hosting a Digifest Satellite Session on the opportunities and risks in integrating social care data and health data.

Scottish Government published its first health and social care data strategy this year. Is it desirable and possible to fully integrate data from health services with data from social care services. This discussion will consider the distinct purposes of social care and health care, and the extent to which these purposes overlap, from the perspectives of not-for-profit service providers and of academic researchers. Speakers will consider the forces which are shaping the development of approaches to health and social care data integration in the UK; similarities and differences in how data use is managed and is being developed in health services and social care services in the UK; and how Scotland can develop approaches to integration which respect the unique contributions of social care services and health services.
